LOCATION

The property is located on the southern side of Victoria Quay on the corner of Watling Street and Victoria Quay in Dublin 8. Watling Street connects Victoria Quay with Thomas Street at its western end.

The site is boarded by the grounds of the Guinness Brewery at its western side. The site overlooks the River Liffey with views over to the National Museum of Ireland.

The area is well served by public transport with the red LUAS line serving Heuston Station less than a 500 metres west of the subject site. There are numerous public and private bus routes in the immediate area providing regular services to and from the city centre.

DESCRIPTION

The asset comprises a three storey semidetached mixed use property extending to 124.06 sq.m. (1,335 sq.ft.) with the ground floor fitted out as a take away. The upper floors provide a one bedroom apartment on each with private balcony. The entire is being sold with the benefit of Vacant Possession.
